#### II. Application:

Applicant Kevin Spring/Epoche International Kitchen, 9199 Olde Eight Rd., Suite D, has applied for a Conditional Use Permit for curbside customer pickup for a carryout restaurant.

Mr. Spring's business is 100% digital restaurant. Not zoned for customers to come into the building. Would like a permit so customers can come in to pick up orders. Orders are only online.

Inspector Saunders said the drive thru pick up is a Conditional Use.

Mr. Spring said they are classified as a takeout restaurant, but right now there is no takeout. Wants customers to be able to pick up their food and leave.

Ms. Bielecki asked if it was like curbside pickup.

Mr. Spring said yes. Customers will call or text that they have arrived in the parking lot.

Ms. Bielecki asked if Mr. Spring had been through health dept. checks.

Mr. Spring said yes, they are fully licensed by Summit County.

Inspector Saunders said that when Mr. Spring first opened, it was strictly home deliveries.

Mr. Spring said that with current situation, vendors can come in such as Door Dash and Uber Eats.

Ms. Bielecki asked about hours of operation.

Mr. Spring said 3-9 PM.
