The chair calls the meeting to order at 6:48 p.m.

A. **DISCUSSION**:

There were no additional comments regarding the proposed text amendment from the previous Public Hearing.

Mr. Schade wrote a draft proposing text amendments regarding pool ladders. He wanted to add to 310.08 H, a new #7 with text about pool ladders. He then read aloud his proposed text.

Mr. Campbell suggested adding "above ground pools" to be specific about the ladders.

Inspector Saunders said in-ground pools should have a locking fence around them.

Ms. Salamon questioned the order of section 310.08 H. She felt that the section should be cleaned up, as it goes back and forth referring to above ground and in-ground pools.

The Zoning Commission decided to send pool ladder regulations to Summit County Planning Commission and would like to work on more pool regulations soon.3-

Mr. Schade also talked about proposed sidewalk regulations. The only regulations for sidewalks are from the ADA. The Zoning Commission reviewed his proposed text amendments for sidewalks.

Ms. Salamon felt text amendments needed to be more specific; what is the regulatory body regarding sidewalks.

Inspector Saunders said the ADA is the regulatory body.

Mr. Schade then reviewed proposed text amendments for portable storage units, adding a new 350.16.

Mr. Schade moved to send to Summit County Planning Commission for their review, the proposed text for sidewalks, pool ladders and portable storage units or roll-off dumpsters.
