He also updated the board on current zoning issues, including a fence that was denied for a corner lot in the Rolling Brooke development for being too high, junk cars on Crestwood are being filed in court, the leaning garage on Crestwood will also be filed. The shed on Brandywine that was constructed without permits is being prosecuted. The construction at 244 Beechwood is an intermittent problem. The Emergency Assistance Center is moving into the plaza on Olde Eight across from the library.
